

R-Ranch Property Owners Association – Gun Range

Assumption of Risk and Liability Minor Children 17 and Under

I apply to use the R-Ranch Shooting Facility provided by the R-Ranch POA. I enter into this agreement in consideration of R-Ranch POA allowing me to use the R-Ranch Shooting Facility by utilizing my personal firearm and/or the use of the R-Ranch owned firearm. I understand that the Shooting Facility will expose me to above normal risk due to the unpredictable nature of firearm(s) use and that many of the risks are beyond the control of R-Ranch POA and its employees. These risks include equipment failures, loss of gun control by shooter in a variety of ways, including being shot by another participant(s). I represent that I have no health or physical conditions that will interfere with my shooting ability or cause me to be more susceptible to injury than the average person. I assume risk associated with any such health or physical condition.

I AGREE TO ASSUME THE RISKS OF INJURY OR DEATH SUFFERED WHILE USING OR BEING A SPECTATOR OF THE SHOOTING FACILITY PROVIDED BY R-RANCH POA. I AGREE TO RELEASE R-RANCH POA AND ITS EMPLOYEES, DIRECTORS, OFFICERS, AND VOLUNTEERS AND FOREVER DISCHARGE AND AGREE TO SAVE AND HOLD HARMLESS AND INDEMNIFY THE R-RANCH POA AND FROM ALL LIABILITY CLAIMS, DEMANDS, CAUSES OF ACTION, AND POSSIBLE CAUSES OF INJURY (INCLUDING DEATH) THAT MAY BE SUSTAINED BY OUR RESPECTIVE OUR RESPECTIVE HEIRS, NEXT OF KIN, OR PERSONAL REPRESENTATIVES WHIL USING THE SAID PREMISSES FROM CAUSE WHATSOEVER INCLUDING NEGLIGENCE OF ANY OF THE FOREGOING.

I agree that I am responsible for my own safety and for the safety of children in my party who are using the R-Ranch POA Shooting Facility with me. Pursuant to Californian Law, I am signing this release on behalf of my children or wards identified below.

I agree that if the R-Ranch POA, its employees, or agents are sued by anyone else for claims related to my conduct or the conduct of my children or wards, I will indemnify the R-Ranch POA, its employees, or agents for all damages.

Permission to use the above property, equipment, and/or facilities as described above may be withdrawn at any time.

SECTION SIXTEEN
GUN RANGE

The most important goals for operation of the Gun Range by R-Ranch management are Safety and Security. All rules will be followed to the letter or range privileges will be suspended. The Gun Range will be open 5 days a week during the summer season (April through October), closed on Monday and Tuesday. During the winter season (November through March) the Gun Range is open by appointment only and 24 hours advance notice must be given to Headquarters.

All owners will show R-Ranch ID, each visit, to R-Ranch personnel upon arrival at the range. Any owner who is not current with R-Ranch assessments or fines will not be allowed access to the range. Every person using the range will sign in on the Gun Range Log each visit before proceeding to any of the facilities. It is the responsibility of every owner using the range to ensure the safety rules are adhered to and understood by every guest they bring to the range. Failure to follow Gun Range personnel direction will result in a \$25.00 fine per incident.

All owners and guests must sign a Liability Waiver once each calendar year along with the Gun Range Safety and/or the Trap & Sporting Clays Range Safety forms. Failure to sign these forms will result in loss of Gun Range privileges. Children under the age of 18 must have an adult present at all times while they are on the Gun Range.

Daily operating times of the Gun Range will be posted on the security gate along with any temporary changes or closures. No owner or guest will enter the Gun Range or use its facilities at any time without Gun Range personnel present.

Absolutely no full-automatic weapons of any kind are permitted anywhere on the Gun Range Shooting Facility. Any shooters who violate this safety rule shall be barred from future use of the Gun Range.

Absolutely NO ALCOHOL shall be consumed while on the Gun Range premises. Any person who is under the influence of alcohol will not be permitted to shoot or remain on the premises
